



Fort Lauderdale Community Bus Service

The City of Fort Lauderdale and Broward County Office of Transportation (BCT) are providing this Community Bus Service to increase the number of destinations that can be reached through Public Transit within the Lauderdale Manors, Lauderdale Villas, Hillmont Heights communities to the African American Research Library, 7th Ave. Health Center, Mizell Center and Downtown Fort Lauderdale.

The Community Bus Service is also designed to connect to BCT routes 1, 6, 9, 10, 11, 14, 20, 22, 30, 31, 36, 40, 50, 60, 81, US 1 Breeze, all Sun Trolley and Housing Authority routes.

The community bus is air-conditioned, wheelchair accessible, and has bike racks.

Hours of Operation Monday - Friday 7:00 am - 5:00 pm

For times and destinations, please refer to the timetable and map on the reverse side.

The community bus will operate as close to schedule as possible. Unforeseen conditions such as bad weather, traffic delays or mechanical difficulties may cause the community bus to arrive earlier or later than scheduled. Please allow yourself enough time when using the service.

The community bus will not operate when a hurricane warning has been issued.
